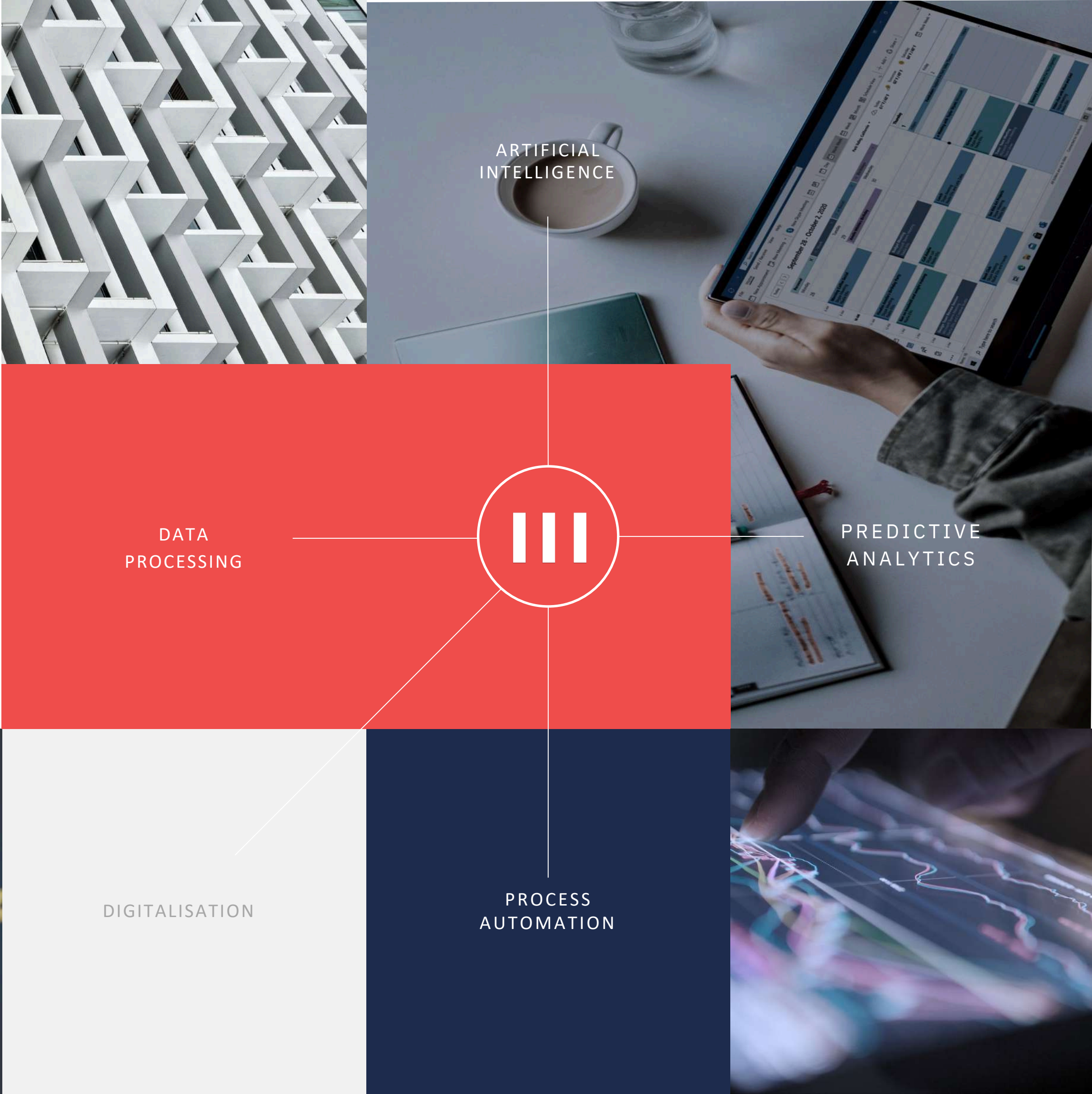

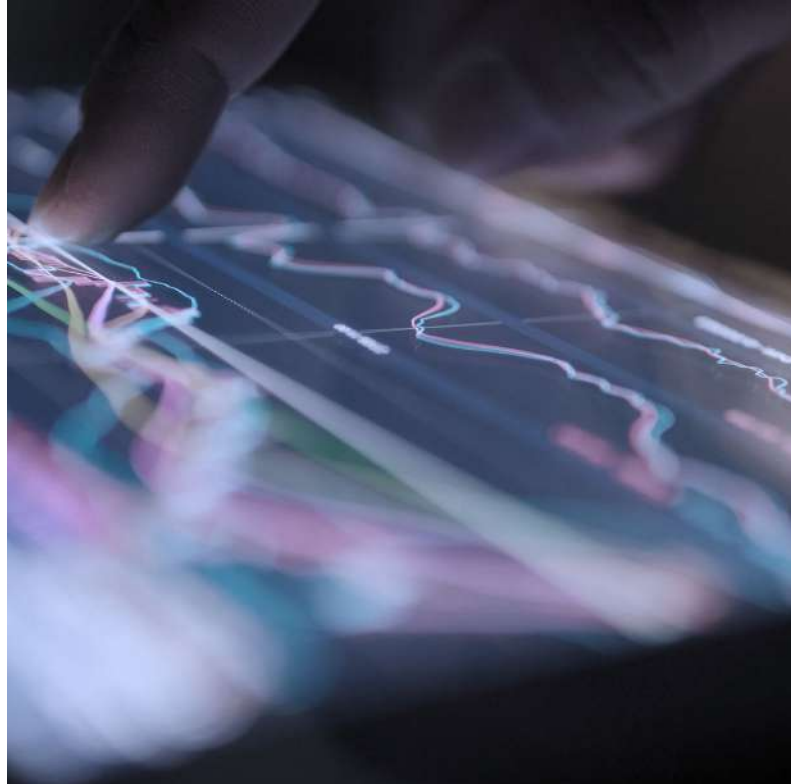

Milk Cartel Case

We have changed the rules of the play

In July 2019, the National Markets and Competition Commission (CNMC in Spanish) fined 10 of the most representative dairy industries in the country for anti-competitive practices. Due to this resolution, farmers who sold milk between 2000 and 2013, whether they are active, retired or have closed their farms, can claim the serious damages suffered.

ESKARIAM has led this cause, through a powerful media campaign to inform farmers about their right to claim and the powerful value proposition offered to defend their interests.

The alliance with the international law firm Hausfeld, a leading firm in the litigation area, and Compass Lexecon, a leading international economic consulting firm, as well as with local law firms close to farmers, has culminated in a massive aggregation of those affected (+ than 2,000) conforming, whoever it might be, the largest case of competition in Europe in recent years.
